
PROJECT LOCATION: near Modesto Lateral Number 1 and Codoni Avenue in Modesto within Stanislaus County

PROJECT DESCRIPTION: The City of Modesto constructed a 25-foot tall, 180 foot-diameter, 4-million-gallon tank, Industrial Tank 13, with a submersible mixer, on the southeast side of Modesto. A 15-20 feet area was paved around the tank for vehicle access. A 3,280-foot² booster pump station, that includes a sodium hypochlorite room, electrical room, pumps, motors, and emergency generator, was installed to the east of the tank. A surge tank, 1.21-million-gallon detention basin, and a grassy swale was also installed on site. Piping from Codoni Avenue to the 4-million-gallon tank, from the tank to the booster pump, and from the booster pump to the Codoni Avenue was installed. Discharge piping from the tank to the basin and from the tank to the sewer system was also installed. A transformer, sliding gate, and 6-foot fencing remained on-site. Construction was completed on October 22, 2018. The tank and infrastructure were constructed to help alleviate water system low-pressure conditions during high demand in Empire Area and the residential area north of Yosemite Boulevard and south of Dry Creek.

PUBLIC AGENCY APPROVING PROJECT AND CARRYING OUT PROJECT: This is to advise that the State Water Board has issued a drinking water supply permit No. 01-10-19PA-006 for the above described Project on April 30, 2019, and has made the following determinations regarding the Project:

1. The Project will not have significant effects on water quality.
2. An Environmental Impact Report (EIR), Supplemental Environmental Impact Report (EIR), and Addendum was prepared for this Project pursuant to the provisions of the California Environmental Quality Act (CEQA).
3. Mitigation measures were not made conditions of the issuance of this permit.
4. A mitigation monitoring and reporting plan was not adopted for this Project.
5. Findings were made pursuant to the provisions of CEQA.
6. A Statement of Overriding Considerations was not adopted for this Project.

This is to certify that the record of permit issuance for the Project is available to the general public at the State Water Board, Division of Drinking Water District Office noted above. The EIR, SEIR, and Addendum is available from the lead agency.
