Project Location (include county): The Project is generally located along State Route (SR) 180 between Post Mile 74.1 and 78.6, southeast of the city of Fresno in Fresno County, California

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Amendment No. 8, a major amendment to the already amended Streambed Alteration Agreement (SAA) number 1600-2013-0194-R4, pursuant to section 1602 of the Fish and Game Code to the Project Applicant, California Department of Transportation (Caltrans).

The Project involves activities related to roadway realignment and widening work on SR 180 where it crosses over the Centerville-Kingsburg Canal, China Slough, Collins Creek, the Kings River, Cameron Slough, Byrd Slough, the Carmelita Canal, and the Mount Campbell Canal. This Major Amendment No. 8 allows a five-year time extension for the SAA and amends the Agreement reflecting changes to Compensatory Measures 3.2 through 3.3.

- 1. The Project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
- 2. CDFW considered the Environmental Impact Report (EIR) prepared by the Lead Agency for this Project pursuant to California Code of Regulations section 15096, subdivision (f).

- 4. A mitigation reporting or monitoring plan was adopted by CDFW for this Project.
