Project Title: Russian River Crossings (Lake or Streambed Alteration Agreement No. 1600-2018-0380-R3)

Project Location: The project is located at two separate locations on the Russian River. The first location is along Vacation Beach Road, west of Orchard Avenue, near the town of Guerneville (38°29'00.36"N, 123°00'39.34"W), and the second location is at the terminus of Washington School Road in Asti near the City of Cloverdale (38°45'52.56"N, 122°58'04.70"W), both in the County of Sonoma.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement number 1600-2018-0380-R3, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Sonoma County DTPW.

The project is limited to the installation and removal of two temporary summer crossings over the Russian River yearly. Both bridges will be installed to increase access to these areas during fire season.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on June 5, 2019 and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were / were not made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was / was not adopted by CDFW for this project.
5. A statement of overriding considerations was not adopted by CDFW for this project.
6. Findings were not made by CDFW pursuant to California Code of Regulations section 15091.
