**Project Title:** Heritage at Carson Creek Village 11 Pedestrian Crossing (Lake or Streambed Alteration Agreement EPIMS Notification No. ELD-28372-R2).

**Project Location (include county):** The project is located on an unnamed tributary to Carson Creek, in the County of El Dorado, State of California; Latitude 38.613019, Longitude -121.066379; located within the greater 423-acre Carson Creek Unit 2 Project site; Assessor's Parcel Number: 117-680-001-000.

**Project Description:** The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement EPIMS Notification No. ELD-28372-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Lennar Homes of California, Inc.

The project is limited to the installation of a permanent 90-foot by 14-foot pedestrian bridge structure that will span the perennial drainage within the Carson Creek Preserve and connect the proposed Heritage at Carson Creek Village 11 bike trail to the existing trail within the Heritage at Carson Creek Unit 2. Bridge abutments will be constructed outside of the ordinary high-water mark of the perennial drainage and will be backfilled following bridge construction. Approaches will be constructed on either side of the pedestrian bridge and disturbed areas/areas of fill will be stabilized with erosion control matting and a seed mix consisting of native upland and wetland species.
