<u>Project Description</u>: The California Department of Toxic Substances Control (DTSC) adopted an Addendum to the previous Initial Study/Negative Declaration (IS/ND) and approved the renewal of an existing Hazardous Waste Facility Post-Closure Permit (PCP), pursuant to authority granted under California Health and Safety Code Chapter 6.5 and California Code of Regulations, Title 22, Division 4.5, Chapter 20.

The current post-closure operations regulated by DTSC at the Facility includes only groundwater monitoring and reporting along with monthly inspection and maintenance of the closure asphalt cap and security fencing. Square D does not conduct any manufacturing, hazardous waste generation or handling or participate in any other activities regulated by DTSC. The Facility has been under this RCRA Post-Closure status for the previous 10 years and it has been managed and continues to be managed under an existing DTSC RCRA Post-Closure Permit. During the past 10 years minor maintenance has been made to the asphalt cap, the fencing, and some minor actions have been conducted related to the monitoring program. For this permit renewal, there will be enhancements made to the monitoring program by the installation of piezometers will be installed to monitor ground water depth and the replacement of a concrete leak detection sump. However, these actions are standard maintenance under the existing permit.

As Lead Agency under the California Environmental Quality Act (CEQA), DTSC approved the above-described project on January 21, 2021 and has made the following determinations:

- 1. The project will not have a significant effect on the environment.
- A Negative Declaration was prepared for this project pursuant to the provisions of CEQA.
- 3. Mitigation measures were not made a condition of project approval.
- 4. A Statement of Overriding Considerations was not adopted for this project.
- 5. Findings were not made pursuant to the provisions of CEQA.
