Project Title: Wild Poppy Road (Infrastructure Segment O) (Streambed Alteration Agreement No. 1600-2018-0311-R2).

Project Location (include county): The project is located at an unnamed tributary to Steelhead Creek, in the County of Placer, State of California; within Sections 3 and 10 of Township 10N, Range 5E; of the U.S. Geological Survey (USGS) 'Rio Linda' 7.5-minute topographic quadrangle, California; approximately centered on Latitude 38.750425°N, Longitude -121.420523°W.


Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement number 1600-2018-0311-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Placer Vineyards Development Group, LLC (Permittee) as represented by Rick Langdon.

The project is a component of the Placer Vineyards Specific Plan (PVSP), a 5,230 acre specific plan project, which includes on- and offsite infrastructure elements. The proposed Segment O Infrastructure Project (Segment O Project) is a 2.12-acre component of the PVSP Backbone Infrastructure, which includes onsite infrastructure elements required for the development of the PVSP, specifically, the installation of a water line, the installation of a storm water drainage pipe/drainage system, an inlet, an outfall, and the construction of a portion of a permanent road (Wild Poppy Road).

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will / will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the environmental impact report prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were / were not made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was / was not adopted by CDFW for this project.
5. A statement of overriding considerations was / was not adopted by CDFW for this project.
