**Project Location (include county):** The project is located on Curry Creek and unnamed tributaries, in the County of Placer, State of California; Assessor's Parcel Numbers 023-221-002. The project site is approximately centered on Latitude 38.748548, Longitude -121.378895 (WGS 84 datum, decimal degrees).

**Project Description:** The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement EPIMS Notification Number PLA-14513-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Lennar Homes of California, Inc.

The Property 1A, Phase 2 Project (project) is a component of the Placer Vineyards Specific Plan (PVSP), a 5,230-acre specific plan area, which includes on- and offsite infrastructure elements. The 181.87-acre project includes both development and infrastructure components. The project area will be mass graded to create housing pads, roads, and associated utilities. Infrastructure elements include a storm water drainage system, excavation of water quality basins within the open space areas, and improvements to Placer Creek Drive.
