

Project Location (Los Angeles County): The project is located in Medea Creek, tributary of Malibu Creek, City of Agoura Hills. The Permittee refers to this section of Medea Creek as "Soft Bottom Channel (SBC) Reach 33". The project site can be located by using the following information: Latitude 34.156147°, Longitude -118.758475°.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed a Lake and Streambed Alteration Agreement (EPIMS-LAN-32863-R5), pursuant to Fish and Game Code section 1602, to the project Applicant, Los Angeles County Public Works. The project is limited to the annual removal of lower willow tree limbs from a portion of SBC Reach 33 and removal of all non-native plants, trash, and debris from the entirety of SBC Reach 33.

This is to advise that CDFW, acting as a Responsible Agency, approved the project described above on 1/23/2023 and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):
