Project Description: UC LBNL would remove and dispose of abandoned foundation elements, utility tunnels, and utility lines beneath the general area of the former Building 51B at the UC LBNL campus. Subsurface elements would be tested for contamination and, as necessary, remediated or removed. In addition, the project would remove a 1,500 gross-square-foot office trailer (Building 51F; installed 1979) that previously resided within the former Building 51B but currently is situated on the outdoor, paved project area.

This is to advise that the University of California (Lead Agency) has approved the above-described project on August 28, 2019 and has made the following determinations:

1. The project will not have more significant effects on the environment than were previously analyzed.
2. An *Environmental Analysis* determined that the project was adequately analyzed in the 2006 Long Range Development Plan Environmental Impact Report (SCH # 2000102046) certified by the Regents in 2007 as supplemented by the *Supplementation of the LBNL 2006 LRDP EIR With Respect to Traffic Impacts at One Intersection* (SCH # 2008122030) and the *Supplementation of the 2006 LRDP EIR With Respect to Greenhouse Gas Emissions and Energy Impacts* (SCH # 2016062007) that the project would not create new or more severe impacts than those identified in the LRDP EIR, as supplemented.
3. Mitigation measures from the prior EIRs were made a condition of project approval.
4. The mitigation reporting or monitoring plan from the prior EIRs was adopted for this project.
5. A statement of Overriding Considerations was adopted for the LRDP EIR which applies to this project.
6. Findings were made pursuant to the provisions of CEQA.
