<p>Project Description: Minor updates to the Los Angeles Valley College Facility Master Plan (Master Plan) that was analyzed in the 2003 Master Plan Final EIR (2003 Final EIR). The 2020 Master Plan Update includes construction of a new Academic Complex and Academic Building, demolition of several outdated buildings (Foreign Language, Engineering, Emergency Services Training, Business & Journalism, Math & Science, Behavioral Sciences, and Humanities), and modernization of campus infrastructure systems.</p> <p>This is to advise that the lead agency Los Angeles Community College District has approved the above described project on February 5, 2020, and has made the following determinations regarding the above described project:</p> <ol style="list-style-type: none"> 1. The Los Angeles Community College District is the Lead Agency. 2. The proposed modifications to the original project described and certified in the 2003 Final EIR will result in no new significant adverse effects or substantially increase the severity of significant effects previously identified. Thus, the current proposed project modifications meet all the conditions for an Addendum. 3. An Addendum to the 2003 Final EIR was prepared for this project by LACCD pursuant to the provisions of CEQA and reflects the independent judgment of LACCD. 4. The mitigation measures that were made a condition of approval of the original project analyzed in the 2003 Final EIR will remain in effect. 5. CEQA Findings of Fact and a Statement of Overriding Considerations were made a condition of approval of the original project analyzed in the 2003 Final EIR.
