Project Title: Guerneville River Park Improvements Phase 2 (Lake or Streambed Alteration Agreement No. 1600-2019-0422-R3)

Project Location: The project is located on the Russian River at 13811 State Highway 116, Guerneville, in the County of Sonoma.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement number 1600-2019-0422-R3, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Sonoma County Regional Parks.

The project is limited to the construction of a concrete non-motorized small-craft hand-launch boat ramp. The concrete boat ramp includes associated rock slope protection. Installation of the boat ramp includes excavating, grading, and bank stabilization. The boat ramp will be constructed along approximately 200 linear feet of the south bank of the Russian River at a gradual slope running along the bank, impacting 2,062 square feet.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on March 16, 2020 and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were / were not made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was / was not adopted by CDFW for this project.
5. A statement of overriding considerations was not adopted by CDFW for this project.
6. Findings were not made by CDFW pursuant to California Code of Regulations section 15091.
