Thank you for your comments in reference to the Forestar Countryside project in Ontario, California. We understand and appreciate your concern for the safety of your district's students and staff. The truck route that will be used to transport excavated soil will not travel in close proximity to your school or other area schools. The main routes to the disposal facilities from the Site are via Chino Avenue to Euclid to Highway 60 or via Chino Avenue to Archibald Avenue to Highway 60. The hours of operation for the site will be 7:00 am to 5:00 pm Monday through Friday and once the workplan is approved, the work will last for approximately 45 days.
