



Description of Project: The Project consists of widening and improving the Esplanade Corridor as a multimodal, "Complete Streets" facility between Eaton Road to the northerly curb returns of the Leora Court/Nord Highway intersection (approximately 0.7 miles in length). The work will increase Esplanade from two to four lanes and includes bicycle, pedestrian, and transit improvements and a raised, landscaped, and irrigated median. Additional work includes installation of new curb, gutter, and 5-foot sidewalk in existing gaps; street lighting; dedicated left-turn pockets; full intersection improvements; driveway entrance improvements; traffic signal conduit; sewer lateral installation; and relocation or undergrounding or utilities.

This is to advise that the City of Chico, as Lead Agency, approved the above-described project on 2/7/2011 and has made the following determinations regarding the above-described project:

- A previously certified EIR, the Northwest Chico Specific Plan EIR (SCH # 2004082087), was used for the subject project.
- 2. The proposed right-of-way improvements are within the scope of the Northwest Chico Specific Plan EIR, and all applicable mitigation measures have been made conditions of project approval.
- 3. Pursuant to Section 15162 of the California Environmental Quality Act no further environmental review is required for the project.


