Notice is hereby given that the County of Monterey is providing the Final Environmental Impact Report (FEIR) on the Paraiso Springs Resort Project (PLN040183, SCH#2005061016) in accordance with the California Environmental Quality Act.

#### PROJECT DESCRIPTION:

The proposed project is a request consisting of the following elements:

- A. An "After The Fact" Demolition Permit, to authorize demolition of the nine historic cottages removed from the Paraiso Hot Springs Resort, November 2003 (to clear Code Violation Case CE030404/PLN040488)
- B. A Combined Development Permit consisting of:
- 1.
