PROJECT LOCATION: Cordua Irrigation District (Cordua) is located in Yuba County. The water will be delivered to the service areas of Dudley Ridge Water District (DRWD), Alameda County Water District (ACWD), County of Kings (KC), and Kern County Water Agency (KCWA). The Project will use existing State Water Project facilities.

#### I. PROJECT DESCRIPTION

Cordua is conducting a one-year 2020 groundwater substitution transfer. Cordua will pump up to an additional 9,198 acre-feet of groundwater from July through September 2020 to substitute for reduced deliveries of surface water under its pre-1914 water right. With deduction of June fisheries release and a 13 percent stream flow depletion, up to 7,142 acre-feet of the forgone surface water will enter the Sacramento-San Joaquin Delta (Delta). After Delta carriage water, DWR will export the water through State Water Project Banks Pumping Plant and deliver to DRWD, ACWD, KC and KCWA during July through September 2020.

#### II. DEPARTMENT'S ACTION

In order to implement this project, DWR must approve an agreement for the conveyance of transfer water.

### III. DETERMINATIONS

This is to advise that DWR, acting as a responsible State agency under the California Environmental Quality Act, has approved the proposed project on and makes the following determinations:

- Yuba County Water Agency prepared an Environmental Impact Report (EIR) pursuant to the California Environmental Quality Act of 1970 (CEQA) and the State CEQA Guidelines in October 2007.
- 2. DWR has determined that said project in its approved form will not have a significant effect on the environment.
- Mitigation measures were adopted by the Lead Agency pursuant to Public Resources Code Section 21081 and by Cordua Irrigation District in its May 15, 2015 Agreement with Yuba County Water Agency.
- 4. A Statement of Overriding Considerations was not adopted for the project, pursuant to Section 15093 of the State CEQA Guidelines.
- 5. Findings were made pursuant to the provisions of Public Resources Code Section 21081 in CEQA.
