Project Location: The project is located at Florin Creek in the Florin community of unincorporated Sacramento County, State of California; Latitude 38.484054, Longitude -121.371995 (WGS 84 datum, decimal degrees). The project is location within the Sacramento County Department of Transportation right-of-way, approximately 0.15 miles north of the intersection of Elk Grove Florin Road and Gerber Road.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement EPIMS Notification No. SAC-32898-R2, pursuant to Section 1602 of the Fish and Game Code to the project Applicant, Lennar Homes of California, Inc. as represented by Larry Gualco.

The project is limited to the installation of a 4-inch polyethylene gas pipe under Elder Creek on the west shoulder of Elk Grove Florin Road using horizontal direction drilling (HDD). The gas line will be installed within an existing public utility easement using two 15-foot long by 4-foot wide bore holes on the north and south side of Elder Creek. The bore depth below Elder Creek will be approximately 9.5-feet. With HDD, no impacts are anticipated to Elder Creek, as the bore pits are located within upland areas and HDD methods can install the gas line below the bed of Elder Creek.
