Project Title: The Woods Stormdrain Outlets N and O Project (Lake or Streambed Alteration Agreement No. EPIMS-RIV-32897-R6)

Project Location (County of Riverside): The Woods Stormdrain Outlets N and O Project (Project) is located on Salt Creek, north of Domenigoni Parkway, south of Simpson Road, east of Interstate 215, and west of Winchester Road within the County of Riverside, State of California; Latitude 33.69563° N, Longitude -117.11189° W. Section 32, Township 5 South, Range 2 West, U.S. Geological Survey (USGS) Winchester, 7.5-minute topographic quadrangle map, San Bernardino Meridian.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement number EPIMS-RIV-32897-R6, pursuant to section 1602 of the Fish and Game Code to the Project Applicant, FPG Tricon Woods Property LLC (Permittee), as represented by Bryan Bergeron.

The Project is limited to the construction of two stormdrain outlets (Line N and Line O) to Salt Creek that will connect future stormdrain systems within Tentative Tracts 32816, 32817, and 32818. The stormdrain outlets will consist of a 48-inch reinforced concrete pipe covered by a concrete apron, a Caltrans type "A" headwall, and a 3-foot thick, 1/4-ton rip-rap dissipation structure.

The Streambed Alteration Agreement is being issued regarding the Project's impacts to fish and wildlife resources subject to Fish and Game Code section 1600 et seq. and associated compensatory mitigation requirements. The Project will permanently impact a total of 0.08 acres and temporarily impact 0.07 acres of fish and wildlife resources pursuant to Fish and Game Code section 1600 et seq. To compensate for permanent impacts to 0.08 acres and temporarily impact 0.07 acres of fish and wildlife resources subject to Fish and Game Code section 1600 et seq., the Project Applicant shall purchase no less than 0.24-acres of Re-establishment credits at Riverpark Mitigation Bank or another CDFW-approved mitigation bank within Western Riverside County, or contribute funds to the Riverside-Corona RCD In Lieu Fee Program for 0.24 acres of re-establishment.

This is to advise that CDFW, acting as a Responsible Agency, approved the Project described above on January 25, 2023 and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

- 1. The project **will not** have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
- 2. CDFW considered the **Mitigated Negative Declaration** prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
- 3. Mitigation measures were made a condition of CDFW's approval of the project.
- 4. A Mitigation Reporting or Monitoring Plan was adopted by CDFW for this project.
