Project Description: The California Department of Fish and Wildlife (CDFW) has executed an extension for Lake and Streambed Alteration Agreement Notification Number 1600-2018-0024-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Lifetime Communities, Inc. as represented by Sukhbir Brar.

The proposed project includes the development of a residential community and associated infrastructure within an 8.5-acre property. The property will establish 17 residential lots, an open space preserve, and a bridge used for vehicular and pedestrian access to the southern half of the lot. The bridge will use utilize an aluminum box culvert design that will span an intermittent drainage on the property.
