Project Location: The project is located at two locations at Gerber Creek in the Vineyard community of unincorporated Sacramento County, State of California at 38.479432, -121.323491, Assessor's Parcel Number (APN) 122-0050-017-0000. The project is located southwest of the intersection of Gerber Road and Vineyard Road.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement No. SAC-17434-R2, pursuant to Section 1602 of the Fish and Game Code to the project applicant, Taylor Morrison, as represented by Jay Pawlek.

The project includes channel and infrastructure improvements associated with residential development of the 192-acre project site.
