Project Title: Menifee North Specific Plan (Lake or Streambed Alteration Agreement No. 1600-2019-0212-R6)

**Project Location (include county):** The Project is located in the County of Riverside, California more specifically within Assessor's Parcel Numbers 457-340-018, 457-340-019, 457-340-020, 457-340-021, 457-340-028, 457-350-008, 457-350-012, 457-350-032. The streambed alteration/construction occurs within the San Jacinto Watershed.

**Project Description:** The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement number 1600-2019-0212-R6, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Diversified Pacific Communities (Permittee) as represented by Nolan C. Leggio.

The Project consists of construction of 211 single-family residential lots with associated roads, culverts, and utilities. Offsite Project areas include road improvements along Watson Road, SR 74, and Sultanas Road, and the construction of new roads along the eastern project boundary. An existing six-inch sewer line will be replaced with an eight-inch line along Sultanas Road to the south of SR-74.
