Project Title: Cooley Ranch – Continuing Water Diversion (Lake or Streambed Alteration Agreement No. 1600-2014-0175-R3)

Project Location: Project is located approximately five miles west of the City of Cloverdale in Sonoma County.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement number 1600-2014-0175-R3, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Klein Foods, Inc.

The project is approval of Water Rights Applications 31304, 31362, and 31363, which involves diversion and use of 226 acre-feet of water per year for the purposes of irrigation and recreation.
