**Project Description:** The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement number 1600-2020-0078-R2-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Solaire Community Builders, LLC, as represented by Jeff Jones.
