Project Title: Barren Ridge Renewable Transmission Project: Barren Ridge Switching Station (Project); Minor Amendment No. 2 to the California Endangered Species Act Incidental Take Permit No. 2081-2013-067-04 (ITP).

Project Location: The Project is located approximately 9 miles north of California City, Kern County, approximately 0.5 mile west of Highway 14, and approximately 0.25 mile north of Pine Tree Road.

Project Description: The Project involves the 14.93-acre expansion of an existing 2.9-acre switching station (for a total 17.83-acre station), including the construction of electrical structures and equipment for transmission lines associated with industrial-sized solar and wind facilities. Project work began in 2014. The Project is expected to result in incidental take of desert tortoise (*Gopherus agassizii*) and Mohave ground squirrel (*Xerospermophilus mohavensis*), which are designated as a threatened species under the California Endangered Species Act. The ITP referenced above, as amended, authorizes incidental take of these two species that may occur as a result of Project implementation. Amendment No. 2 allows for the use of biological monitors to assist designated biologists and replaces a figure attachment, correcting a discrepancy.
