Project Title: South Sacramento Habitat Conservation Plan (SSHCP), California Endangered Species Act Incidental Take Permit No. 2081-2018-016-02 (ITP).

Project Location: The Planning Area encompasses approximately 317, 655 acres within south Sacramento County. The Planning Area includes Galt and Galt's sphere of influence, and the portion of Rancho Cordova that is located south of U.S. Highway 50. The geographical boundaries of the Planning Area are U.S Highway 50 and White Rock Road to the north, the Sacramento River levee and County Road J11 (Walnut Grove-Thornton Road) to the west, the Sacramento County line with El Dorado and Amador Counties to the east, and the San Joaquin County line to the south.

Project Description: The Project is a multi-jurisdictional, multi-species, 50-year HCP implementation that will cover 28 native species, (seven of which are State listed species) through minimizing and mitigating impacts on those species and their habitats. The Project will allow for the development of 67,618-acres for urban development within the UDA included within the Plan Area. The UDA is defined as all lands within the Sacramento County Urban Services Boundary (USB) that are also within the Plan Area (this includes lands within the Rancho Cordova city limits that are within the Plan Area); and all lands within Galt's city limits and within the City of Galt's sphere of influence. The USB was defined by Sacramento County as the maximum boundary where they are willing to provide future urban services, such as sanitary sewer and water supply. The scope of work outside of the UDA is limited to infrastructure and transportation projects.

The Project includes the development, operation, and maintenance of new urban development structures, public facilities, and utilities; preserve management and monitoring; habitat enhancement, re-establishment, and establishment; species surveys and research; adaptive management activities; and all other activities as detailed in the SSHCP.

The Covered Activities would also include implementation of the SSHCP Conservation Strategy, including management and monitoring of the proposed SSHCP Preserve System, habitat enhancement and re-establishment/establishment, species surveys, monitoring, research and adaptive management activities for the Preserve located inside and outside the UDA. The SSHCP Conservation Strategy is designed to provide mitigation for all unavoidable SSHCP Covered Activity effects, including direct and indirect, temporary and permanent, and cumulative effects to Covered Species modeled habitats and Covered Species individuals.

The Covered Activities will result in impacts to 33,497 acres of Covered Species California tiger salamander (*Ambystoma californiense*), giant garter snake (*Thamnophis gigas*), tricolored blackbird (*Agelaius tricolor*), Swainson's hawk (*Buteo swainsoni*), slender Orcutt grass (*Orcuttia tenuis*), Sacramento Orcutt grass (*Orcuttia viscida*) and Boggs Lake hedge-hyssop (*Gratiola heterosepla*) habitat. Project impacts include direct and indirect, temporary and permanent, and cumulative effects to Covered Species modeled habitats and Covered Species individuals. The project is expected to result in incidental take of Covered Species, which are designated as a threatened/endangered species under the California Endangered Species Act. The ITP referenced above as issued by CDFW authorizes incidental take of species listed under CESA that may occur as a result of Project implementation.

INSTRUCTIONS FOR THE NOTICE OF DETERMINATION FORM

A Notice of Determination (NOD) should be completed and filed with the Office of Planning and Research in Sacramento every time the Department of Fish and Wildlife (CDFW) carries out, funds or approves a project that is not exempt under the California Environmental Quality Act (CEQA). The following template was created to simplify the process of NOD completion.

Instructions:

- The project location and project description should be very short (2-4 lines) but should provide an accurate summary of the location and nature of the project. Ensure the completed form is not more than 2 pages in length.
- Change the default selections on the NOD form to match the document. The default selections on the form assume that: 1) CDFW is acting as a responsible agency, 2) the lead agency prepared a negative declaration, and 3) no significant effects were identified by CDFW. These default settings can easily be changed by double-clicking on the appropriate boxes and changing the "default value" from "checked" to "not checked" or vice-versa.
- Item 6 on the form should state that findings were made pursuant to Public Resources Code section 21081(a) only when CDFW is approving the ITP in reliance on an environmental impact report (EIR). In all other cases where CDFW is relying on a negative declaration or mitigated negative declaration to issue the permit, the form should indicate findings under Public Resources Code section 21081(a) were not made. Where CDFW is relying on a negative declaration or mitigated negative declaration to approve the permit and findings under Public Resources Code section 21081(a) were not made, the next sentence stating that other findings were adopted by CDFW to document compliance with CEQA should be included. Where CDFW is relying on an EIR and findings were made under Public Resources Code section 21081(a), the sentence regarding the adoption of other findings to document compliance with CEQA should be deleted.
- Remember to attach the project proponent's receipt showing payment of environmental filing fees to the Department. If fees have not yet been paid and CDFW has not issued a no effect determination for the project, payment in the appropriate amount must be provided before the NOD can be filed.

OGC can also assist you with filing of a NOD at the Office of Planning and Research's State Clearinghouse. The notice must be filed within five working days of when CDFW decides to carry out or fund a project, or of when it issues a permit or otherwise approves the project.
