Subject: Notice of Assumption of Jurisdiction under 25 C.F.R. §2.20 (c) by the Assistant Secretary – Indian Affairs over appeals by Viejas Band of Kumeyaay Indians and The Sycuan Band of Kumeyaay Nation; and the County of San Diego, California

We are submitting a supplemental Administrative Record to the previous record sent by memorandum dated July 2, 2019. This supplemental Administrative Record is adding all the documentation from the 2017 IBIA Administrative Record to the current appeal from the Viejas Band of Kumeyaay Indians, the Sycuan Band of Kumeyaay Nation, and the County of San Diego, California, that the Interior Board of Indian Appeals received on May 24, 2019.

On June 7, 2019, the Board received by memorandum dated June 6, 2019, a notice from the Assistant Secretary – Indian Affairs indicating that she is exercising her authority under 25 C.F.R. §2.20 (c) and 43 C.F.R. §4.332 (b) to assume jurisdiction over these appeals.

On June 10, 2019, the Board sent the above notice transferring the appeals to the Assistant Secretary.

Per your Memorandum dated June 6, 2019, on Assumption of Jurisdiction concerning the acquisition of land into trust for the Ewiiapaayp Band of Kumeyaay Indians, we are forwarding the Supplemental Administrative Record to Carol Brown at Office of the Assistant Secretary – Indian Affairs, U.S. Department of the Interior, 1849 C Street, NW, MS-4660-MIB, Washington, DC, 20240.
