**Project Description:** The California Department of Toxic Substances Control (DTSC) adopted an Addendum to the previous Negative Declaration and approved the modifications of the David H. Fell & Company, Inc. (DHF) Standardized Hazardous Waste Permit (Permit). DHF is a precious metal recycling facility that reclaimed precious metals from hazardous waste. DHF is currently conducting closure activities according to the current Permit's Closure Plan. This Class 1\* Permit Modification amends the closure plan and allows DHF to compare closure samples for soil, concrete, and equipment, with residential screening levels for silver, to confirm the closure performance standard has been met.

As a Lead Agency under the California Environmental Quality Act, DTSC approved the above-described project on October 1, 2019 and has made the following determinations:

1. The project will not have a significant effect on the environment.
2. A Negative Declaration was prepared for this project pursuant to the provisions of the California Environmental Quality Act.
3. Mitigation measures were not made a condition of project approval.
4. A Statement of Overriding Considerations was not adopted for this project.
5. Findings were not made pursuant to the provisions of California Environmental Quality Act.
