Project Description (Proposed actions, location, and/or consequences).

The Sacramento River Bank Protection Project (SRBPP) is a continuing construction project authorized by Section 203 of the Flood Control Act of 1960. The purpose of this project is to provide protection to the existing levee and flood control facilities of the Sacramento River Flood Control Project. To date, work has been carried out in two phases, with a total of about 820,000 feet of river stabilized under the project. Current SRBPP work is being conducted under Phase II of its existing federal authorization. The supplemental authorization of 80,000 linear feet is in addition to the previously constructed 820,000 linear feet.

Identify the project's significant or potentially significant effects and briefly describe any proposed mitigation measures that would reduce or avoid that effect.

The EIS/EIR found that the proposed program, when mitigation is considered, would have less-than significant effects on these resources: Flood control and geomorphology; Water quality and groundwater; Geology, soils, seismicity and minerals; Transportation and navigation; Air quality and climate change; Noise; Vegetation and wetlands; Fisheries and aquatics; Wildlife; Land use and agriculture; Recreation; Population and housing; Utilities and public services; Aesthetics; Public health and environmental hazards; Cultural resources; Socioeconomics and environmental justice

The proposed program would result in significant and unavoidable effects on the resources: Air quality and climate change (Generation of Construction/Operational GHG Emissions); Noise (Exposure of Sensitive Receptors); Vegetation and wetlands (Loss Special Status Plant Populations); Wildlife (Loss of Riparian Habitat); Land use and agriculture (Conversion of Important Farmland); Recreation (Long-Term Reduction within the Levee Corridor); Aesthetics (Affect a Scenic Vista); and Cultural resources (Disturbance of Native American or Historic Period Human Remains).

A few proposed program mitigation measures during construction include: Monitor Turbidity; Implement a Traffic Control and Road Maintenance Plan; Site Safety Measures; Notify Recreation Users of Potential Construction Hazards; Minimize GHG Emissions, Reduce Operational Emissions below Federal de minimis. Compensate for the Loss of Woody Riparian Habitat; Compensate for the Loss of Wetlands, Other Waters, Protected Trees, Fish Habitat and Spawning Habitat.
