The California High-Speed Rail Authority (Authority) announces the availability of the Merced to Fresno Section: Central Valley Wye Final Supplemental Environmental Impact Report/Environmental Impact Statement (Final Supplemental EIR/EIS) of the California High-Speed Rail Project, pursuant to the California Environmental Quality Act (CEQA) and the National Environmental Policy Act (NEPA).

The Authority has prepared this document as a supplement to its 2012 Final EIR/EIS for the Merced to Fresno Section (Merced to Fresno Final EIR/EIS). Following completion of the Merced to Fresno Final EIR/EIS in May 2012, the Authority and FRA approved portions of the "Preferred Alternative" (i.e., the Hybrid Alternative) outside the wye for the north-south HSR alignment and the Downtown Merced and Downtown Fresno Mariposa Street station locations. Both agencies deferred a decision on the area known as the "wye connection," which refers to the HSR connection between the east-west San Jose to Merced Section to the west and the north-south Merced to Fresno Section to the east, to allow for consideration of additional wye alternatives. The Final Supplemental EIR/EIS describes and analyzes these additional wye alternatives and thus supplements the analysis and conclusions of the Merced to Fresno Final EIR/EIS.

The environmental review, consultation, and other actions required by applicable federal environmental laws for the project are being or have been carried out by the State of California pursuant to 23 United States Code 327 and a Memorandum of Understanding (MOU) dated July 23, 2019, and executed by the FRA and the State of California. Under that MOU, the Authority is the project's lead agency under NEPA. Prior to the July 23, 2019, MOU, the FRA was the federal lead agency. The Authority is the project's lead agency under CEQA.

The Final Supplemental EIR/EIS is being made available to the public and agencies prior to an anticipated meeting of the Authority's Board of Directors on September 10, 2020. The document will be available to the public on **Friday**, **August 7**, **2020**.

The Final Supplemental EIR/EIS includes the Authority's responses to the comments received on the previously circulated Draft Supplemental EIR/EIS and Revised/Second Draft Supplemental EIR/EIS. Consistent with the Draft Supplemental EIR/EIS, the Final Supplemental EIR/EIS identifies the SR 152 (North) to Road 11 Wye Alternative as the Authority's Preferred Alternative.

whether to certify the Final Supplemental EIR/EIS and approve the Preferred Alternative pursuant to CEQA. The Authority's Board of Directors will also consider whether to direct the Authority's Chief Executive Officer to issue a Supplemental Record of Decision for the Merced to Fresno Section selecting the Preferred Alternative in the Authority's role as NEPA lead agency. A court reporter will be available at the meeting to record public comments.
