Project Description: The California Department of Toxic Substances Control (DTSC), pursuant to authority granted under California Health and Safety Code Chapter 6.5 and California Code of Regulations, Title 22, Division 4.5, Chapter 20, proposes to approve a Class 1* Permit Modification (Modification) for the Hazardous Waste Facility Permit. The Modification will incorporate minor administrative edits to the operations plan and physical description of Unit AC22, the Fluidized Bed Reactor.

The modifications to the permit document minor alterations to the design and process as a result of final design and field engineering during construction. The design changes include adjustments to piping routes, pump details, and to reflect tank and container dimensions. The previously approved total capacity of Unit AC22 will be reduced due to the removal of Tank T-504, with a capacity of 20,000 gallons. With the removal of Tank T-504, three smaller tanks, T-530, T-540, and T-550 with a combined storage capacity of 9,266 gallons were incorporated into Unit AC22. The permit modification will allow for the activation and use of previously approved Unit AC22 to manage hazardous waste.

As Lead Agency under the California Environmental Quality Act (CEQA), DTSC approved the above-described project on March 3, 2020 and has made the following determinations:

1. The project will not have a significant effect on the environment.
2. A Negative Declaration was prepared for this project pursuant to the provisions of CEQA.
3. Mitigation measures were not made a condition of project approval.
4. A Statement of Overriding Considerations was not adopted for this project.
5. Findings were not made pursuant to the provisions of CEQA.
