

Project Description: The California Department of Toxic Substances Control (DTSC) adopted an Addendum to the previous Negative Declaration and approved the modifications of the Hazardous Waste Facility Post-Closure Permit, which include changes in property ownership from The Chemours Company FC, LLC (Chemours) to North Point Development Company (NP OAKLEY, LLC), key Chemours personnel, addition of Senate Bill 673 requirements, and to provide informational updates to the current cleanup status of the site. No physical changes to the site are proposed.

As Lead Agency a Responsible Agency under the California Environmental Quality Act (CEQA), DTSC approved the above-described project on August 28, 2019 and has made the following determinations:

1. The project will will not have a significant effect on the environment.
2. A Negative Declaration Mitigated Negative Declaration Environmental Impact Report was prepared for this project pursuant to the provisions of CEQA.
3. Mitigation measures were were not made a condition of project approval.
4. A Statement of Overriding Considerations was was not adopted for this project.
5. Findings were were not made pursuant to the provisions of CEQA.
