Pursuant to CEQA Guidelines Section 15095, Disposition of a Final EIR, the San Mateo County Mosquito and Vector Control District is hereby informing you that the Board of Trustees certified its Final PEIR on the District's Integrated Mosquito and Vector Management Program (IMVMP) and adopted the IMVMP on January 9, 2019. The Notice of Determination was filed with the appropriate county clerks and State Clearinghouse on January 10, 2019. As the Lead Agency, the District is making the Final PEIR available to you to download from its website: <https://www.smcmvcd.org/programmatic-environmental-impact-report-peir> or on a CD, upon request.

The Notice of Availability of an initial Draft PEIR was issued on March 21, 2016, and the District held a public hearing for comments on the Draft PEIR on April 20, 2016. The District proceeded to prepare a revised Draft PEIR that was released on July 19, 2018, and held a public hearing on August 22, 2018. A Final PEIR including responses to comments received and text revisions to the revised Draft PEIR was completed in December 2018.

Because the District would like to coordinate with your agencies on general plans, specific plans, development projects, open space and habitat conservation plans, and species recovery plans that could affect our mosquito and vector control activities within our Service Area, please include us on your mailing list for CEQA documents originating with your agencies. Feel free to contact me for input on vector control measures to consider in your plans and programs going forward.
