Project Title: Pleasanton Ridge Livestock Pond Restoration Project (Lake or Streambed Alteration Agreement No. 1600-2019-0217-R3)

Project Location: The project is located within Pleasanton Ridge Regional Preserve on Eden Canyon Road at Vogel Lane in the County of Alameda, State of California; Latitude 37.39'8.11 Longitude -121.57'6.29.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement number 1600-201-0217-R3, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Matt Graul/East Bay Regional Park District.

The project is limited to sediment removal and embankment/spillway repair on existing livestock ponds.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project on September 17, 2019, and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were / were not made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was / was not adopted by CDFW for this project.
5. A Statement of Overriding Considerations was not adopted by CDFW for this project.
6. Findings were not made by CDFW pursuant to Public Resources Code section 21081, subdivision (a).
