Title: Low-Energy Offshore Geophysical Permit Program (OGPP) Update

Applicant: Multiple Applicants (see below at end of the Description for individual entities)

Location: Offshore waters (to 3 nautical miles) from Mexico border to Oregon border.

Description: The California State Lands Commission has statutory authority, pursuant to Public Resources Code section 6826, to issue geophysical permits in State waters to qualified permittees for the use of low energy geophysical equipment to perform geophysical surveys of the ocean bottom, subject to specified terms and conditions. The California State Lands Commission action is issuing a 3-year non-exclusive geophysical survey permit to Ecosystems Management (A3781), Merkel & Associates, Incorporated (A3696), Miller Marine Scientific and Consulting, Incorporated (A3698), Sulmara Subsea Incorporated (A3776), and Terrasond Limited (A3699).
