 - Execution of amended Oil and Gas Emission Reduction Agreement (Original-SJVUAPCD-2060168, Kern County Agreement#890-2016) for clarification on PM2.5 and implementation of MM4.2-8 (Air Quality).
 - 3. Deletion of MM 4.17-5 (Utilities and Service Systems) Disadvantaged Community Drinking Water Grant Fund.
 - 4. Adoption by resolution of the Voluntary Disadvantaged Community Drinking Water Grand Fund for oil and gas permits.




