Project Location: The project is located along unnamed tributaries to Elk Grove Creek, off of Grant Line Road, in the city of Elk Grove, County of Sacramento, State of California; Latitude 38.4018º N, Longitude -121.3441º W.

Project Description: The California Department of Fish and Wildlife (Department) has extended Streambed Alteration Agreement number 1600-2015-0171-R2, pursuant to Section 1602 of the Fish and Game Code with the project Permittee, Lennar Homes of California as represented by Larry Gualco.

The Project consists of development of 365 single-family residences, open-space/drainage lots, two water quality treatment basins, roadways, and a community park. Project activities covered under the Agreement include mass grading and fill of 0.961 acres of aquatic resources, and construction of two water quality treatment basins with associated outfalls to unnamed tributaries.
