Project Location (include county): The project is located at University Creek and its tributaries, south of West Sunset Boulevard, west of Fiddyment Road, east of Pettigrew Road, and north of Pleasant Grove Creek, in the County of Placer, State of California; Latitude 38.816667°, Longitude -121.384722°; Sections 1, 2, 10, 11, and 14, Township 11N, Range 5E, U.S. Geological Survey (USGS) map 'Pleasant Grove', Mount Diablo base and meridian; Assessor's Parcel Numbers (APNs) 017-020-017-510 and 017-010-054-000.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement number 1600-2018-0243-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Brookfield Sunset, LLC, as represented by John Norman.

The project is a component of the Amoruso Ranch Specific Plan, a, approximately 694-acre mixed use housing development plan.
