Project Title: CV Link Multi-Modal Transportation Project <b>(Palm Desert's Painters Path Improvements; Cooperative Agreement)</b>

General Project Location (City and/or County): City of Palm Desert, Riverside County		
<p>Project Description: CVAG has been working with member jurisdictions as to construction plans for CV Link. The design and location of CV Link in Palm Desert is primarily on-street, making it different than other cities. The Palm Desert City Council took actions at its September 12, 2019 meeting, and additional ratification actions at its September 26, 2019 meeting related to CV Link. As approved, the City's minor modifications to CV Link include enhanced designs; the connection of CV Link to the City's commercial districts, trail system, and to Hovley Lane East; improved access points; and an in-channel (Whitewater River) berm crossing. To reflect these approvals, the City also approved a General Plan Amendment that changed the designation of Painters Path from "local street" to "enhanced secondary roadway".</p> <p>As it pertains to CVAG's more limited action, the City approved a Cooperative Agreement ("Agreement") with CVAG that addresses reimbursement for certain improvement-related costs and confirms that the City's improvements will be built consistent with CV Link's previously approved engineering plans.</p> <p>To analyze the City's approvals under CEQA, the City adopted an addendum to the EIR that was previously certified by CVAG in 2017. The City's addendum confirms that the impacts of the City's proposed CV Link</p>		

modifications are within the envelope of the impacts previously analyzed and disclosed in CVAG's EIR.

On September 30, 2019, CVAG's Executive Committee authorized CVAG's Executive Director to execute the Cooperative Agreement with the City of Palm Desert, and received and filed the City's Addendum to CVAG's previously certified EIR for CV Link. The Committee found that it (i) had considered the Addendum prepared by the City in connection with CVAG's previously certified EIR; (ii) agreed that the Addendum accurately captures the potential environmental effects of the City's proposed CV Link modifications; and (iii) agreed that no further CEQA review is required beyond CVAG's previously certified EIR and the City's Addendum pursuant to Public Resources Code 21166 and State CEQA Guidelines 15162.

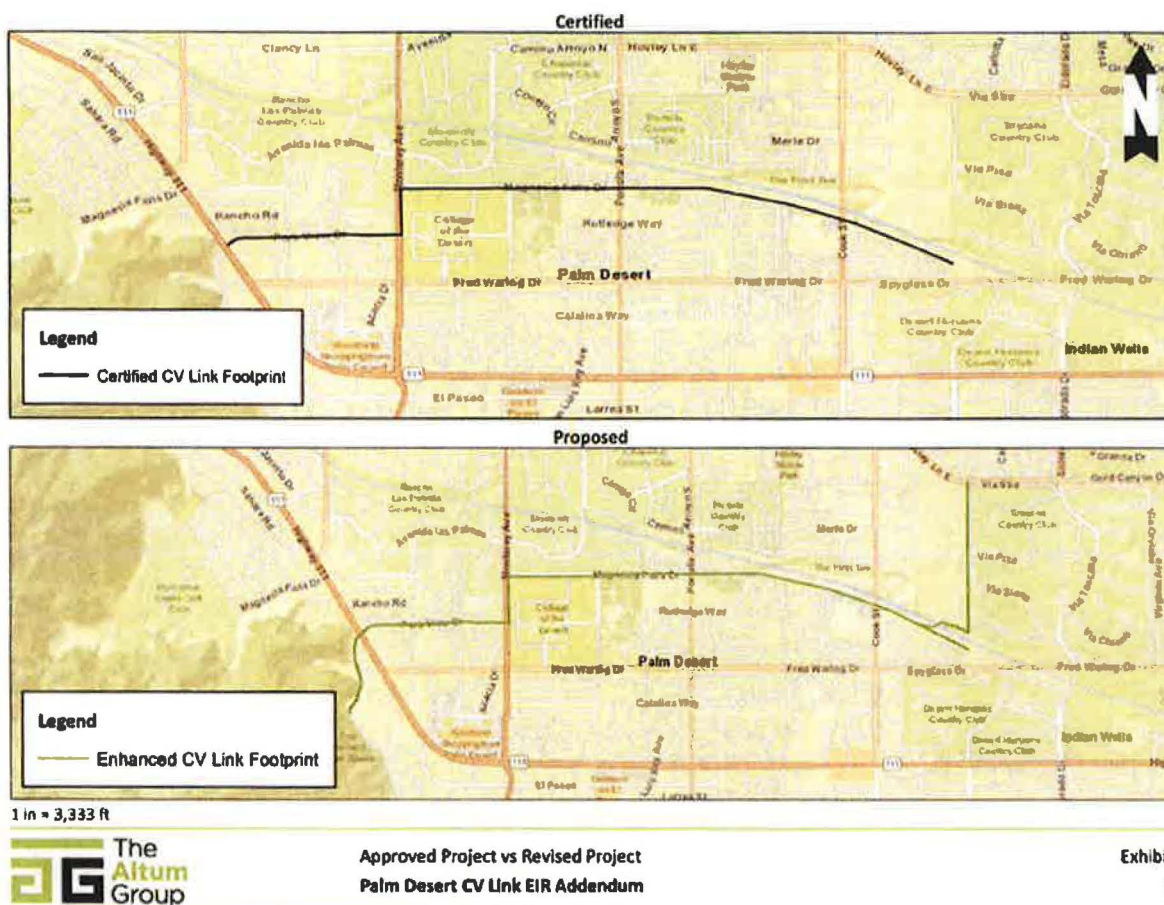

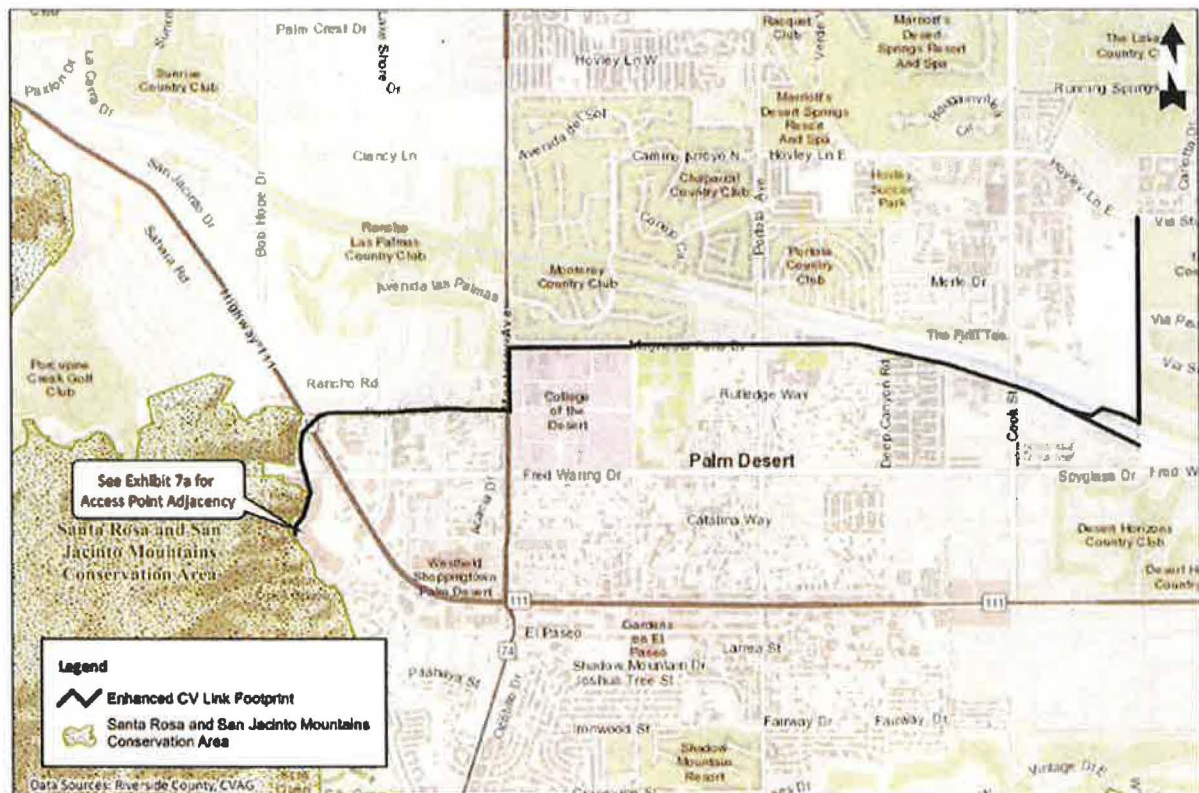
## Exhibit 1 Project vs Revised Project
