Location: Approximately 116 acres of State fee-owned school lands (Assessor's Parcel Numbers 449-111-23 and 449-111-26) located in lots 10, 11, and 12, containing 38.14 acres, 37.64 acres and 40.06 acres, respectively, all within section 30, T4N, R1E, San Bernardino Baseline & Meridian, San Bernardino County. This State parcel is situated east of Victorville in a remote area of Lucerne Valley in the Mojave Desert.

Description: Revision of a conditional use permit to expand the mining area of an existing 215 acre pit by 113 on a total of 328 acres and approval of Reclamation Plan. The State Lands Commission action is an issuance of a 7-year Mineral Extraction Lease through June 30, 2030.
