**Project Title:** Dry Creek habitat Enhancement Project – Phase 2, Part 2 (Reach 14) (Lake or Streambed Alteration Agreement No. 1600-2018-0083-R3)

**Project Location:** The Project area is located within the Dry Creek Valley and would be along Dry Creek in the Reach 14 area approximately 1/2- mile downstream of Warm Springs Dam (3333 Skaggs Springs Rd), in the County of Sonoma.

**Project Description:** The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement number 1600-2018-0083-R3, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Sonoma County Water Agency.

The Project consists of the habitat enhancements within the second of the six required restoration miles. The footprint of impact for Reach 14 will be approximately 6.24 acres over a 0.77-mile long stretch of Dry Creek. In total, this project will enhance approximately 6.19 acres over 0.77 stream miles. Project activities would consist of actions such as dewatering, diverting creek flows around work area, stockpiling of materials, removal of vegetation, excavation of the habitat enhancement feature areas, and placement of boulder and log structures.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on September 19, 2019 and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):
