**PROJECT TITLE:** Eastern Municipal Water District – Well 28 Replacement

**PROJECT LOCATION:** 1930 E. Mountain Avenue, City of San Jacinto, CA

**PROJECT DESCRIPTION:** The Eastern Municipal Water District proposed Project includes replacement of existing collapsed Well No. 28 with new Well No. 38 located within the same well site property. The project involves drilling and equipping new potable Well No. 38 at the existing site at a similar depth and yield, construction of a new well structure to house the well, and repurposing the existing well house to house the chlorination equipment.

**PUBLIC AGENCY APPROVING PROJECT AND CARRYING OUT PROJECT:** This is to advise that the State Water Resources Control Board (State Water Board) has issued a drinking water supply permit **05-20-20PA-006** for the above described Project on **April 29, 2020**.
