## NOTICE OF AVAILABILITY REVISED DRAFT ENVIRONMENTAL IMPACT REPORT (RDEIR)

PROJECT TITLE: CARMEL LAGOON ECOSYSTEM PROTECTIVE BARRIER,

Notice is hereby given that the County of Monterey is seeking written comment on the Revised Draft Environmental Impact Report (RDEIR) on the Carmel Lagoon Ecosystem Protective Barrier, Scenic Road Protection Structure, and Interim Sandbar Management Plan Project (REF120051, SCH#2014071050) in accordance with the California Environmental Quality Act (CEQA). The public review period will begin on February 2, 2024 and end on March 20, 2024. This public review period is established for the purpose of receiving written comments on the accuracy and adequacy of the RDEIR together with other information relative to the environmental effect of the proposed project described below.

**Project Description:** This Notice of Availability is for the RDEIR for the proposed Carmel Lagoon Ecosystem Protective Barrier (EPB), Scenic Road Protection Structure (SRPS), and Interim Sandbar Management Plan Project (ISMP) (proposed project) (REF120051, SCH# 2014071050).

On December 2, 2016, the County of Monterey, as Lead Agency, released the Draft Environmental Impact Report (Draft EIR) for the proposed project. The Draft EIR evaluated the environmental impacts associated with the construction and operation of the three proposed project components: 1) EPB; 2) SRPS; and 3) ISMP, with the primary objective of implementing a solution to improve the functions and values of the ecosystem in and around the Lagoon by restoring the Lagoon's historic hydrologic, pre-management conditions to the extent feasible, and to protect and improve habitat for fish and wildlife while maintaining flood protection in the area.

The proposed EPB project component would maintain existing flood protection to low-lying homes and public infrastructure along the northern edge of the Lagoon, while the frequency of mechanical management of the sandbar is reduced in compliance with regulatory requirements. The proposed SRPS project component would provide protection from erosion along the northern sand cliffs and from the undermining

of Scenic Road, which may result from northerly river flows or large ocean swells. The proposed ISMP project component is intended to provide a short-term (i.e., until the design, environmental review, permitting, and construction of the proposed EPB and SRPS project components are completed) solution to potential flooding issues by implementing select sandbar management actions that would allow additional natural function in the Lagoon while still protecting properties and infrastructure.

The Draft EIR public review period ended on January 31, 2017, which included a 15-day extension to the required 45-day review period. During this time period, public agencies, organizations, and the public had the opportunity to review the Draft EIR and submit comments regarding the Draft EIR and proposed project in accordance with California Code of Regulations (CCR) Section 15087 of the CEQA Guidelines.

In response to public comments on the Draft EIR, the County of Monterey elected to conduct additional technical studies and environmental analyses associated with project alternatives, which resulted in revisions to the following chapters of the Draft EIR: Introduction; Summary; Alternatives; CEQA Considerations; List of Preparers; Environmental Setting (topical sections Aesthetics, Biological Resources, Geology and Soils, Hydrology and Water Quality, Transportation and Energy); and Appendices. No changes have been made to the proposed project description or footprint, or the remaining sections of the Draft EIR.

In accordance with California Public Resources Code Section 21092.1 and CEQA Guidelines CCR Section 15088.5, the County of Monterey is recirculating portions of the Draft EIR (in the form of the RDEIR) in response to new information and to provide the public with a meaningful opportunity to comment on the additional information. The recirculation is "partial" (meaning that only chapters or portions of the prior Draft EIR with new information have been revised and reissued) rather than "full" (meaning that the entire document has been revised and reissued).
