**Project Title:** Lone Road Over Willow Creek Bridge Replacement Project (Streambed Alteration Agreement No. 1600-2017-0245-R2).

**Project Location (include county):** The project is located at Willow Creek, in the County of Sacramento, State of California; Latitude 38° 24' 57.16" N, Longitude 121° 02' 18.86"W; Township 07N, Range 09E, Section 31, of the Carbondale U.S. Geological Survey (USGS) Quadrangle.

**Project Description:** The California Department of Fish and Wildlife (Department) has executed Lake and Streambed Alteration Agreement number 1600-2017-0245-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Sacramento County.

The amendment is limited to revising Section 3 of the Agreement to remove requirements for a conservation easement because existing land use restrictions or planning documents do not provide opportunity for future development of mitigation areas.

This is to advise that the Department, acting as a Responsible Agency, approved the above described project on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):
