**PROJECT DESCRIPTION:** The District proposed to construct a new pumping station with a capacity of 13,000 gpm and with space allowances for two future pumps, install facilities for onsite chlorination generation to provide increased chlorine residual in the distribution system, convert the Fairmont Reservoir from imported water to groundwater storage, meet fire suppression capacity and water service demand in the District's developing northern and eastern areas, and improve system reliability. The Project would also include associated onsite yard piping, demolition of the existing Fairmont Pumping Station once the new facility is in operation, and construction of 1,000 feet of pipeline in Fairmont Boulevard.

Specific activity related to the water supply permit include:


1. Installation of onsite hypochlorite generation system at the Fairmont Pump Station.

**PUBLIC AGENCY APPROVING PROJECT AND CARRYING OUT PROJECT:** This is to advise that the State Water Board has issued a drinking water supply permit 05-08-19PA-010 for the above described Project on November 19, 2019, and has made the following determinations regarding the Project:

1. The Project will not have significant effects on the environment.
2. A Mitigated Negative Declaration (MND) was prepared for this Project pursuant to the provisions of the California Environmental Quality Act (CEQA).
3. Mitigation measures were made a condition of the District's approval of the project.
4. A mitigation monitoring and reporting plan was adopted by the District for this Project.
5. A Statement of Overriding Considerations was not adopted by the District for this Project.
6. Findings were made pursuant to the provisions of CEQA.
