(EIR)/ENVIRONMENTAL ASSESSMENT (EA) FOR THE GROVE AVENUE CORRIDOR PROJECT (SCH

2014101071)

The City of Ontario (City) and the California Department of Transportation (Caltrans) propose to widen Grove Avenue from a four-lane roadway to a six-lane roadway from Interstate 10 (I-10) to State Street/Airport Drive in the City of Ontario. The project would alleviate existing and anticipated future congestion, improve traffic operations and mobility, and provide continuity along Grove Avenue in conformance with the City of Ontario's General Plan Circulation Element.

In compliance with the California Environmental Quality Act (CEQA), the City and Caltrans prepared and circulated the Draft EIR/EA for the project from August 19 and October 2, 2019. During this public review period, a total of 12 written comments from various agencies and interested parties were received by the City and Caltrans. Pursuant to Section 15088 of the CEQA Guidelines, the City has prepared individual responses to all of these comments. The response to your comment letter is attached.

The Final EIR incorporates the changes that have been made to the Draft EIR/EA based on the comments and the responses to comments. The Final EIR is available and can be downloaded from the City's website: <a href="https://www.ontarioca.gov/Planning/Reports/EnvironmentalImpact">https://www.ontarioca.gov/Planning/Reports/EnvironmentalImpact</a>. The full Responses to Comments document is provided as Appendix J of the Final EIR.

The City and Caltrans have identified the Build Alternative as the preferred alternative. Caltrans is planning to issue the Finding of No Significant Impact (FONSI) in accordance with the National Environmental Policy Act (NEPA) after the Final EIR is certified.

The City Council has scheduled a meeting to certify the Final EIR on July 20, 2021, at 6:30 p.m. The meeting will be held in-person, in the City Council Chambers, Ontario City Hall, 303 East B Street, Ontario, California 91764. Please note that in-person City Council meetings have limited seat in order to practice social distancing. Community Rooms 1 and 2, located next to the City Hall lobby, will be available for overflow seating. Face coverings and social distancing are required in order to attend in-person.
