On September 8, 2015, the City of Azusa certified the Dhammakaya International Meditation Center (DIMC) Specific Plan Environmental Impact Report (EIR), adopted Findings of Fact and a Mitigation Monitoring and Reporting Program (MMRP), and approved the DIMC Project (Project). The Project includes demolition of the existing Montserrat Building, the Xavier Center meeting hall, and eight one-story Organizational Housing buildings, and the construction of a Meditation Hall, nine two-story Organizational Housing buildings, a storage/workshop building, a stormwater detention/water quality basin, a fire access road, additional parking, a reflecting pool, and landscaping.

On October 17, 2016, the City approved Addendum No. 1 to the DIMC Specific Plan EIR and adopted the Specific Plan Amendment (SPA No. 1) to allow site plan and design modifications to the Project.

Pursuant to the project applicant's Design Review application to modify and implement Phase 1 of the development plan for the Project, as well as a number of small design changes, the City has prepared a second

Addendum (Addendum No. 2) to the DIMC Specific Plan EIR to evaluate the potential for any new significant impacts, or a substantial increase in the severity of previously identified significant impacts, to occur. Addendum No. 2 determined that neither the Project modifications, nor any changes in circumstances surrounding the Project, result in any new significant impact, or substantially increase the severity of an impact identified in the 2015 EIR. The Addendum further determined that no new mitigation is required beyond those measures in the previously adopted MMRP.
