Project Title: Folsom Phase 2 Water Pipeline (Streambed Alteration Agreement EPIMS Notification No. SAC-29617-R2)

Project Location: The project is located at Humbug Creek and Willow Creek and their associated tributaries in the City of Folsom, in the County of Sacramento, State of California. The project occurs at six (6) locations at three (3) existing culverts, two (2) existing bridges, and one (1) roadside ditch.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement EPIMS Notification No. SAC-29617-R2, pursuant to Section 1602 of the Fish and Game Code to the project Applicant, the City of Folsom as represented by Steve Krahn.

The project is limited to the installation of a 28-inch steel water pipeline. The pipeline will extend approximately 3.6 miles, running from Iron Point Road northwest along East Bidwell Street, north along Oak Avenue Parkway, and west along the Oak Parkway Trail to the existing City of Folsom Water Treatment Plant. While the pipeline installation will occur primarily within existing paved roads or other developed area, the pipeline includes six (6) watercourse crossings.

This is to advise that CDFW, acting as a Responsible Agency, executed the above Streambed Alteration Agreement for the project on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):
