Project Title: Aspen VIII and IX (Streambed Alteration Agreement No. 1600-2016-0233-R2)

Project Location: The project is located on Elder Creek, in the County of Sacramento, State of California; Latitude; 38° 30' 39.26" N, Longitude 121° 18' 52.19" W, Township 8N, Ranch 6E, Sections 27, 28, and 34 of the Carmichael U.S. Geological Survey (USGS) Quadrangle.

Project Description: The California Department of Fish and Wildlife has extended Streambed Alteration Agreement No. 1600-2016-0233-R2, pursuant to Section 1602 of the Fish and Game Code to the project Permittee, Teichert Materials as represented by Justin Stein.

The project is limited to 1) excavation and removal of irrigation and roadside ditches on site, 2) the upgrading the existing, undersized culverts on Elder Creek at Elder Creek Road with new box culverts, and 3) installation of a weir structure within the 100-year floodplain to allow potential peak flows from the creek to flow into a detention basin (located outside the 100-year floodplain). This will extend the Streambed Alteration Agreement term from February 2022 to February 2027.
