Dear Ms. Woods:

This letter documents the Phase I cultural resources records search conducted by Dudek for the College Boulevard Improvement Project (project), located in Oceanside, San Diego County, California (Figure 1). The project proposes improvements to College Boulevard, including expanding the road width. Large portions of the project area have been previously assessed for cultural resource sensitivity (Clowery-Moreny and Smith 2008; Stropes 2014), and the construction corridor was found to be completely developed or previously disturbed. In consideration of the character and severity of impacts relating to previous development, and an observed general low potential for encountering intact not-yet-identified cultural resources, these previous studies recommended no further cultural resources mitigation be required for those portions of the project area.

Dudek completed an updated inventory of the entire project alignment. A South Coastal Information Center (SCIC) records search indicated that no cultural resources have been recorded in the proposed project area. A search of the Native American Heritage Commission's (NAHC) Sacred Lands File does not suggest the presence of any tribal cultural resources. To date, representatives from the Viejas Band of Kumeyaay Indians and Pala Tribal Historic Preservation Office have responded to outreach letters from Dudek, both requesting that a Native American monitor be present during ground disturbance.

This records search was conducted in accordance with the standards and guidelines defined by the California Environmental Quality Act (CEQA). Although the project alignment is obscured by the existing road, areas along the existing road were opportunistically inspected. In consideration of the character and severity of impacts relating to previous development, and the low potential for encountering yet-identified intact cultural resources that have been

reported in the present and previous technical investigations, no further cultural resources construction monitoring or other mitigation is recommended to be necessary.

PROJECT DESCRIPTION AND LOCATION

The project proposes improvements to College Boulevard, including expansion from four to six lanes, enhancement of existing and future traffic operations, improvements for congestion relief, improvements of safety conditions for unsignalized intersections, and construction of safer travel routes for bicyclists and pedestrians. The project area consists of College Boulevard from Old Grove Road south to Waring Road (Figure 2). The project area falls within Sections 15, 22, and 27 of the U.S. Geological Survey San Luis Rey 7.5-minute quadrangle (Township 11S; Range 4W).

REGULATORY CONTEXT

The following section provides a summary of the applicable regulations, policies, and guidelines relating to the proper management of cultural resources.

The California Register of Historical Resources

In California, the term “historical resource” includes “any object, building, structure, site, area, place, record, or manuscript which is historically or archaeologically significant, or is significant in the architectural, engineering, scientific, economic, agricultural, educational, social, political, military, or cultural annals of California” (Public Resources Code (PRC) Section 5020.1(j)). In 1992, the California legislature established the California Register of Historical Resources (CRHR) “to be used by state and local agencies, private groups, and citizens to identify the state’s historical resources and to indicate what properties are to be protected, to the extent prudent and feasible, from substantial adverse change” (PRC Section 5024.1(a)). The criteria for listing resources in the CRHR, enumerated in the following text, were developed to be in accordance with previously established criteria developed for listing in the National Register of Historic Places (NRHP). According to PRC Section 5024.1(c)(1–4), a resource is considered historically significant if it (i) retains “substantial integrity,” and (ii) meets at least one of the following criteria:

- (1) Is associated with events that have made a significant contribution to the broad patterns of California’s history and cultural heritage
- (2) Is associated with the lives of persons important in our past

- (3) Embodies the distinctive characteristics of a type, period, region, or method of construction, or represents the work of an important creative individual, or possesses high artistic values
- (4) Has yielded, or may be likely to yield, information important in prehistory or history

To understand the historic importance of a resource, sufficient time must have passed to obtain a scholarly perspective on the events or individuals associated with the resource. A resource less than 50 years old may be considered for listing in the CRHR if it can be demonstrated that sufficient time has passed to understand its historical importance (see 14 California Code of Regulations (CCR) 4852(d)(2)).

The CRHR protects cultural resources by requiring evaluation of the significance of prehistoric and historic resources. The criteria for the CRHR are nearly identical to those for the NRHP, and properties listed or formally designated as eligible for listing in the NRHP are automatically listed in the CRHR, as are state landmarks and state points of interest. The CRHR also includes properties designated under local ordinances or identified through local historical resource surveys.

California Environmental Quality Act

As described further in the following text, the following CEQA statutes and CEQA Guidelines are of relevance to the analysis of archaeological, historic, and tribal cultural resources:

- PRC Section 21083.2(g) defines “unique archaeological resource.”
- PRC Section 21084.1 and CEQA Guidelines Section 15064.5(a) define “historical resources.” In addition, CEQA Guidelines Section 15064.5(b) defines the phrase “substantial adverse change in the significance of an historical resource.” It also defines the circumstances when a project would materially impair the significance of a historical resource.
- PRC Section 21074(a) defines “tribal cultural resources.”
- PRC Section 5097.98 and CEQA Guidelines Section 15064.5(e) set standards and steps to be employed following the accidental discovery of human remains in any location other than a dedicated ceremony.

The NAHC resolves disputes regarding the disposition of human remains. In addition, the Native American Historic Resource Protection Act makes it a misdemeanor, punishable by up to 1 year in jail, to deface or destroy a Native American historic or cultural site that is listed or may be eligible for listing in the CRHR.

California Health and Safety Code Section 7050.5

California law protects Native American burials, skeletal remains, and associated grave goods, regardless of their antiquity, and provides for the sensitive treatment and disposition of those remains. California Health and Safety Code Section 7050.5 requires that if human remains are discovered in any place other than a dedicated cemetery, no further disturbance or excavation of the site or nearby area reasonably suspected to contain human remains can occur until the County Coroner has examined the remains (Section 7050.5b). PRC Section 5097.98 also outlines the process to be followed in the event that remains are discovered. If the County Coroner determines or has reason to believe the remains are those of a Native American, the coroner must contact the California NAHC within 24 hours (Section 7050.5c). The NAHC will notify the most likely descendant. With the permission of the landowner, the most likely descendant may inspect the site of discovery. The inspection must be completed within 48 hours of notification of the most likely descendant by the NAHC. The most likely descendant may recommend means of treating or disposing of, with appropriate dignity, the human remains and items associated with Native Americans.

PRC Sections 21083.2(b)–(c) and CEQA Guidelines Section 15126.4 provide information regarding the mitigation framework for archaeological and historic resources, including examples of preservation-in-place mitigation measures. Preservation-in-place is the preferred manner of mitigating impacts to significant archaeological sites because it maintains the relationship between artifacts and the archaeological context, and may also help avoid conflicts with religious or cultural values of groups associated with the archaeological site.

Under CEQA, a project may have a significant effect on the environment if it may cause “a substantial adverse change in the significance of an historical resource” (PRC Section 21084.1; CEQA Guidelines Section 15064.5(b)). If a site is either listed or eligible for listing in the CRHR, or if it is included in a local register of historic resources, or identified as significant in a historical resources survey (meeting the requirements of PRC Section 5024.1(q)), it is a “historical resource” and is presumed to be historically or culturally significant for the purposes of CEQA (PRC Section 21084.1; CEQA Guidelines Section 15064.5(a)). The lead agency is not precluded from determining that a resource is a historical resource, even if it does not fall within this presumption (PRC Section 21084.1; CEQA Guidelines Section 15064.5(a)).

A “substantial adverse change in the significance of an historical resource” reflecting a significant effect under CEQA means “physical demolition, destruction, relocation, or alteration of the resource or its immediate surroundings such that the significance of an

historical resource would be materially impaired” (CEQA Guidelines Section 15064.5(b)(1); PRC Section 5020.1(q)). In turn, the significance of a historical resource is materially impaired when a project does any of the following:

- (1) Demolishes or materially alters in an adverse manner those physical characteristics of an historical resource that convey its historical significance and that justify its inclusion in, or eligibility for, inclusion in the California Register; or
- (2) Demolishes or materially alters in an adverse manner those physical characteristics that account for its inclusion in a local register of historical resources pursuant to Section 5020.1(k) of the PRC or its identification in an historical resources survey meeting the requirements of Section 5024.1(g) of the PRC, unless the public agency reviewing the effects of the project establishes by a preponderance of evidence that the resource is not historically or culturally significant; or
- (3) Demolishes or materially alters in an adverse manner those physical characteristics of a historical resource that convey its historical significance and that justify its eligibility for inclusion in the California Register as determined by a lead agency for purposes of CEQA [CEQA Guidelines Section 15064.5(b)(2)].

Pursuant to these guidelines and definitions, the CEQA inquiry begins with evaluating whether a project site contains any “historical resources,” then evaluates whether that project will cause a substantial adverse change in the significance of a historical resource such that the resource’s historical significance is materially impaired.

If it can be demonstrated that a project will cause damage to a unique archaeological resource, the lead agency may require reasonable efforts be made to permit any or all of these resources to be preserved in place or left in an undisturbed state. To the extent that they cannot be left undisturbed, mitigation measures are required (Section 21083.2(a), (b), and (c)).

Section 21083.2(g) defines a unique archaeological resource as an archaeological artifact, object, or site about which it can be clearly demonstrated that without merely adding to the current body of knowledge, there is a high probability that it meets any of the following criteria:

- (1) Contains information needed to answer important scientific research questions and that there is a demonstrable public interest in that information

- (2) Has a special and particular quality such as being the oldest of its type or the best available example of its type
- (3) Is directly associated with a scientifically recognized important prehistoric or historic event or person

Impacts to non-unique archaeological resources are generally not considered a significant environmental impact (PRC Section 21083.2(a); CEQA Guidelines Section 15064.5(c)(4)). However, if a non-unique archaeological resource qualifies as a tribal cultural resource (PRC 21074(c); 21083.2(h)), further consideration of significant impacts is required.

CEQA Guidelines Section 15064.5 assigns special importance to human remains and specifies procedures to be used when Native American remains are discovered. These procedures are detailed in PRC Section 5097.98 and described in the following text.

Native American Historic Cultural Sites

State law (PRC Section 5097 et seq.) addresses the disposition of Native American burials in archaeological sites and protects such remains from disturbance, vandalism, or inadvertent destruction; establishes procedures to be implemented if Native American skeletal remains are discovered during construction of a project; and established the NAHC.

In the event that Native American human remains or related cultural materials are encountered, Section 15064.5(e) of the CEQA Guidelines (as incorporated from PRC Section 5097.98) and California Health and Safety Code Section 7050.5 define the subsequent protocol. In the event of the accidental discovery or recognition of any human remains, excavation or other disturbances must be suspended at the site and any nearby area reasonably suspected to overlie adjacent human remains or related material. Protocol requires that a county-approved coroner be contacted to determine if the remains are of Native American origin. Should the coroner determine the remains to be Native American, the coroner must contact the NAHC within 24 hours. The most likely descendent may make recommendations to the landowner or the person responsible for the excavation work for means of treating, with appropriate dignity, the human remains and any associated grave goods, as provided in PRC Section 5097.98 (14 CCR 15064.5(e)).

SCIC RECORDS SEARCH

A records search for the proposed project area and a surrounding 0.5 mile was completed by a Dudek archaeologist at the SCIC on May 27, 2016 (Confidential Appendix A). This search included mapped prehistoric, historical, and built-environment resources; Department of Parks

and Recreation Site Records; technical reports; archival resources; and ethnographic references. Additional consulted sources included the NRHP, California Inventory of Historical Resources/CRHR, listed Office of Historic Preservation Archaeological Determinations of Eligibility, California Points of Historical Interest, California Historical Landmarks, and California Department of Transportation Bridge Survey information.

Previously Conducted Studies

SCIC records indicate that 28 cultural resources investigations have been previously conducted within a 0.5-mile radius of the proposed project area. Of these, five studies have been conducted within portions of the College Boulevard alignment and adjacent temporary work areas (Table 1). Studies by Clowery-Moreny and Smith (2008) and Stropes (2014) were previously conducted for iterations of the College Boulevard widening project, but only a portion of the present project area was included. No studies have been conducted in the current project area since Stropes (2014).

Clowery-Moreny and Smith 2008 and Stropes 2014

Clowery-Moreny and Smith (2008) conducted the initial records search and survey of the widening of College Boulevard. The 2008 records search did not identify any previously recorded resources within the project area, and the survey did not identify any new cultural resources. Clowery-Moreny and Smith (2008) determined that the construction corridor was completely developed or previously disturbed, and recommended that no further cultural resources management was required. Stropes (2014) was an assessment update of Clowery-Moreny and Smith (2008). The records search identified no resources within the project corridor, and the survey determined that the construction corridor was completely developed and void of cultural resources. The updated records search recommended that no further cultural resource management was required.

Previously Identified Cultural Resources

SCIC records indicate that no cultural resources have been previously identified within the proposed project area. Four prehistoric archaeological sites (P-37-000632, P-37-004979, P-37-010445, and P-37-010446) and one historic address have been previously recorded within a 0.5-mile radius of the project area. P-37-000632 and P-37-004979 consist of darkened, possibly midden, soil and shell. A mano fragment was identified at P-37-000632, but no formal artifacts were identified at P-37-004979. P-37-010445 and P-37-010446 consist of prehistoric artifact scatters that include ceramic

fragments, lithic flakes, mano fragments, and metate fragments. All of these prehistoric sites are located at least 1,000 feet from the project site. The historic residence is located on Cedar Road, 0.5 mile east of the project alignment (Confidential Appendix A).

NAHC SACRED LANDS FILE SEARCH

Dudek requested a search of NAHC's Sacred Lands File on May 25, 2016, for the proposed project area. The NAHC provided results on May 27, 2016. This search failed to indicate the presence of Native American traditional cultural places within this area or the surrounding 0.5-mile buffer (Appendix B). The NAHC additionally provided a list of Native American tribes and individuals/organizations that might have knowledge of cultural resources in or near the project area.

TRIBAL CORRESPONDENCE

Following the NAHC response, letters were sent on June 13, 2016, to the listed tribal representatives requesting information, opinions, or concerns relating to the proposed project (Appendix B). The letters contained a brief description of the planned project and a reference map. Follow-up calls were made on June 27, 2016. To date, representatives from Viejas Band of Kumeyaay Indians (June 21, 2016) and Pala Tribal Historic Preservation Office (June 27, 2016) have responded to Dudek's outreach letters; both requested that a Native American monitor be present during ground disturbance, and asked to be updated on any future findings.

RECONNAISSANCE SURVEY

Dudek archaeologist Matthew DeCarlo conducted a survey of the proposed project area on July 5, 2016. Due to the substantial development of project area, the survey methodology consisted of driving the project route to identify any undeveloped areas that could be subject to pedestrian survey. Pedestrian survey would have been conducted using formal transects at 10-meter intervals. Vehicular survey of the project area proved that there were no undeveloped areas, so a pedestrian survey was not conducted. The vehicular survey identified no built environment resources, and a review of historic aerial maps confirmed that College Boulevard and the surrounding built environment were constructed within the modern era.

SUMMARY AND MANAGEMENT RECOMENDATIONS

Dudek's Phase I cultural resources inventory of the project area suggests that there is low potential for the inadvertent discovery of cultural resources during ground-disturbing activities. The NAHC Sacred Lands File search did not indicate the presence of Native American cultural resources in the vicinity of the project area. To date, no tribal correspondence has suggested that



any cultural resources are located within the project area; however, Native American monitoring has been requested. No archaeological or built environment resources were observed during a reconnaissance-level site inspection. SCIC records indicate that no archaeological resources have been recorded within the project area, four prehistoric sites and one historic address have been recorded within a 0.5-mile radius of the project area. None of these resources would be impacted by the project. Large portions of the project area have been previously inventoried (Clowery-Moreny and Smith 2008; Stropes 2014). These studies did not identify any cultural resources, the construction corridor was observed to be completely disturbed, and the studies recommended that no further cultural resource mitigation or construction monitoring be required.

No further cultural efforts or mitigation, including cultural construction monitoring, are recommended to be necessary in support of implementation of the current project. In the unlikely event that archaeological material be identified by project personnel during earth-moving activities, work would be temporary halted, and the City of Oceanside would be consulted. A qualified archaeologist would be assigned to review the unanticipated find, and evaluation efforts of this resource for CRHR listing would be initiated, in consultation with the City of Oceanside. Should human remains be discovered, work would halt in that area and procedures set forth in the California Public Resources Code (Section 5097.98) and State Health and Safety Code (Section 7050.5) would be followed, beginning with notification to the lead agency and County Coroner. If Native American remains are present, the County Coroner would contact the NAHC to designate a most likely descendent, who would arrange for the dignified disposition and treatment of the remains.

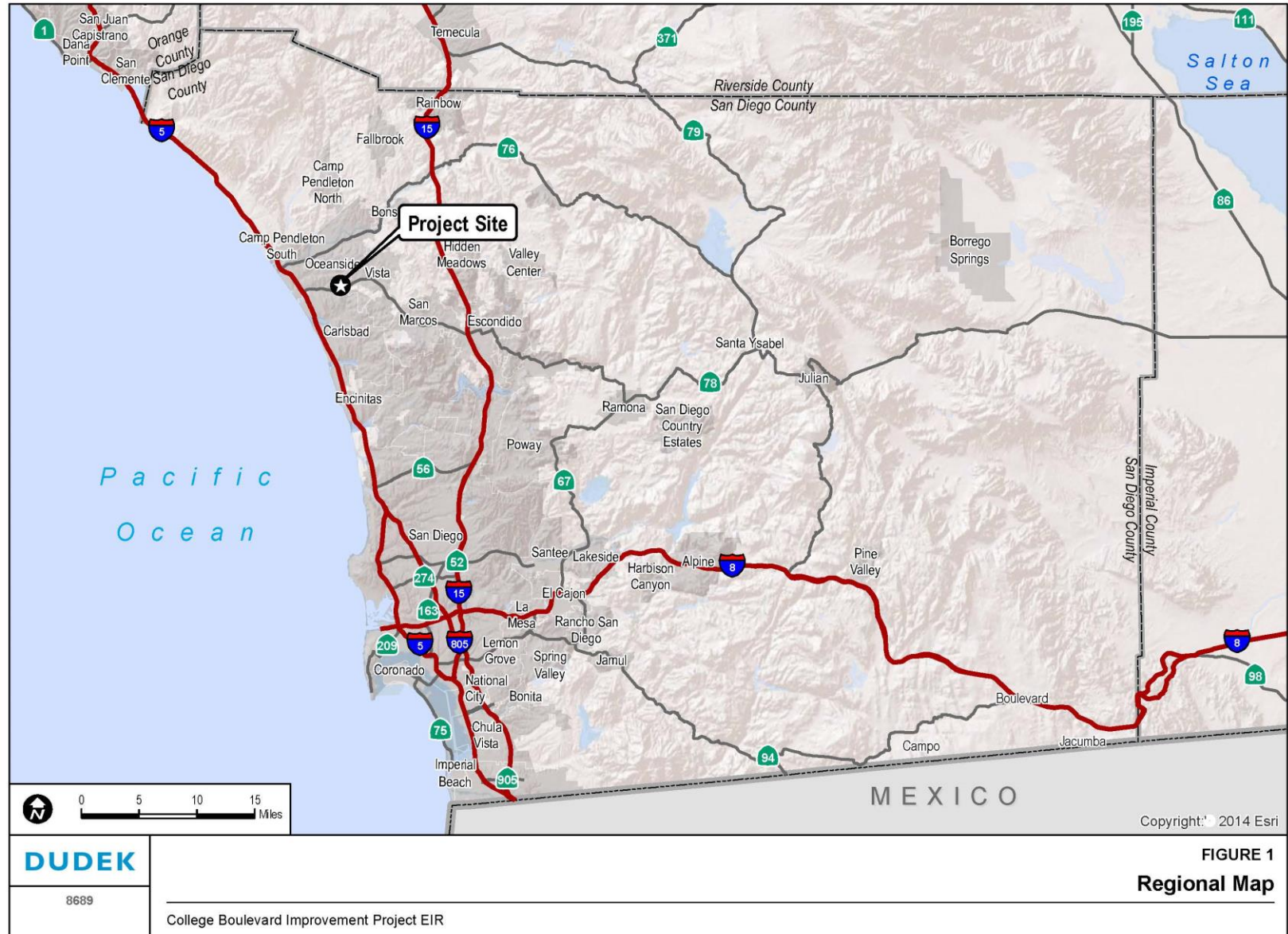

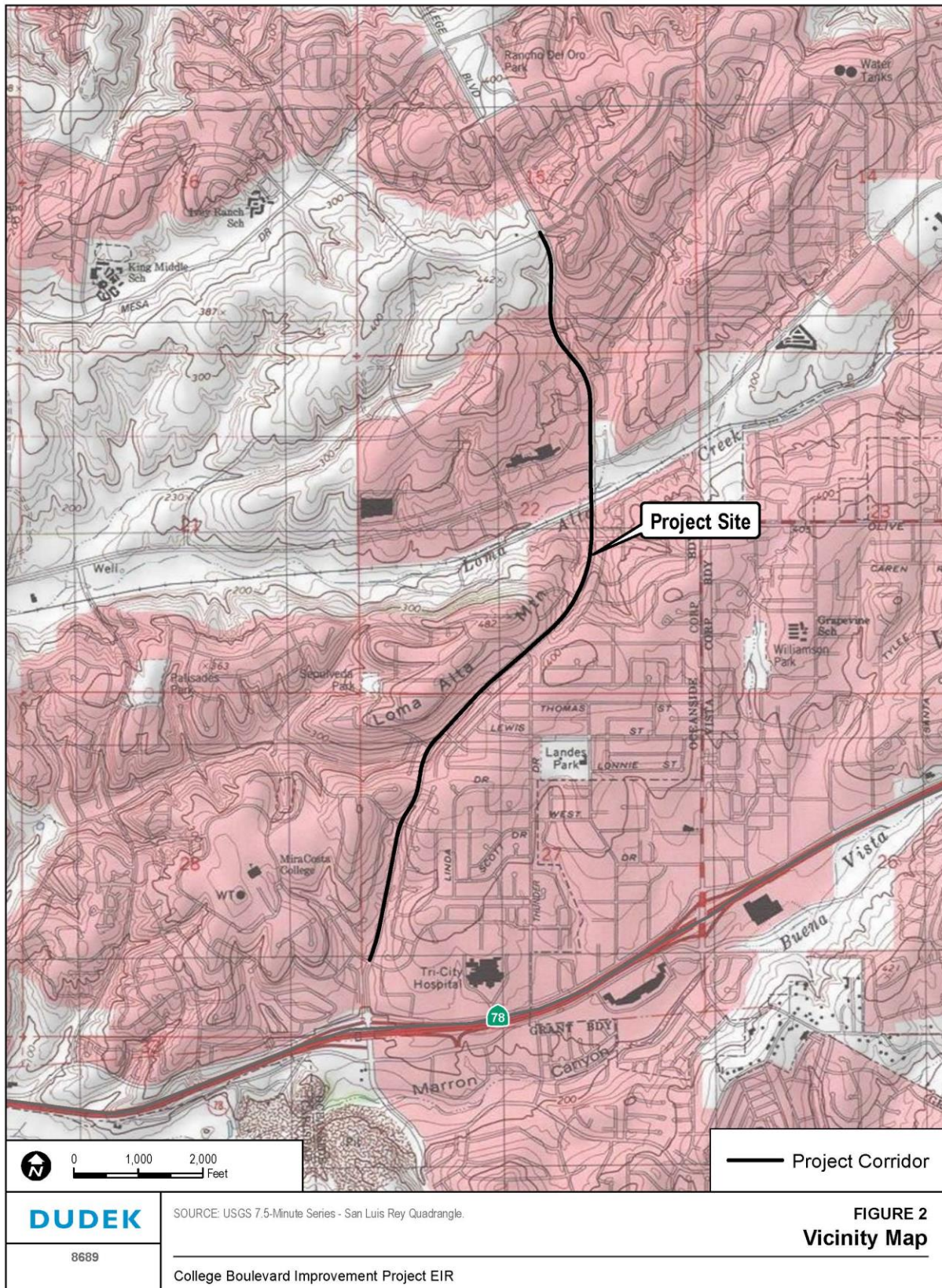



Dudek is conducting a cultural resources inventory for the College Blvd Improvement Project. The project site consists of College Blvd and extends from Old Grove Rd to Waring Rd in Oceanside, California (Figure 1). The project is located in Section 15, 22, and 27, Township 11 South, and Range 4 West of the U.S. Geological Survey (USGS) San Luis Rey 7.5' quadrangle.

Dudek is requesting a NAHC search for any sacred sites, traditional cultural properties, or other Native American cultural resources that may fall within a one-mile buffer of the proposed project location (Figure 1). Please provide contact information for all Native American tribal representatives that should be consulted regarding these project activities. This information can be faxed to 760-632-0164.
