**Project Title: Humeke Water Diversion and Stream Crossings Project (Lake or Streambed Alteration Agreement No. 1600-2017-0706-R1)**

**Project Location:** The project to be completed is located within the Mattole River watershed, approximately 1 air mile SW of Thorn Junction, County of Humboldt, State of California. The project is located in Section 05, T05S, R02E, Humboldt Base and Meridian; in the Briceland U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 215-241-072; latitude 40.0524 N and longitude 123.9758 W at the point of water diversion.

**Project Description:** The project is limited to two (2) encroachments. One encroachment is for water diversion from Bridge Creek (up to 0.3 acre-feet annually) used solely for domestic purposes. Work for the water diversion will include use and maintenance of the water diversion infrastructure. The other proposed encroachment is to remove a failing culvert and restore the stream channel. Work for this stream crossing encroachment will include excavation, removal of the failing culvert and associated fill prism followed by stream channel restoration as specified in the Notification.

This is to advise that CDFW, acting as  the Lead Agency /  a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A  mitigated negative declaration /  negative declaration was prepared for this project pursuant to the provisions of CEQA.  
CDFW considered the  mitigated negative declaration /  negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
