Project Title: Waits Culvert Replacement Project (Lake or Streambed Alteration Agreement No. 1600-2018-0452-R1)

Project Location (include county): The project to be completed is located within the Norton Creek watershed, approximately 1.5 miles northeast of the town of McKinleyville, County of Humboldt, State of California. The project is located in Section 29, T2N, R1E, Humboldt Base and Meridian; in the Arcata North U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 511-122-013; latitude 40.9649, N and longitude 124.0947 W.

Project Description: The project is limited to one encroachment. Work for the encroachment will include the replacement of an existing 12" culvert with a minimum 30" diameter culvert at a road/stream crossing. The work for this project will include excavation, removal of the old culvert, replacement with a new culvert, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
